Over the summer the Sheridan School District conducted lead tests on all drinking fountains and kitchens in district owned buildings. The great news is that all but one of the tested locations was below the recommended limit. In several locations lead was not detectable in the water. The one location that tested above the limit was the band room in the Old Gym at FCS and our facilities team will have a filter installed and the sink retested before school starts. If the work is not completed there will be alternate water available.

UPDATE: We received the results of the tests from the Old Gym at Faulconer-Chapman School after the filters were installed. The results show that all of the water fixtures in the Old Gym now test well below safe levels. Thank you to our maintenance department for taking care of this quickly. The health and safety of our students is our top priority.
